

IRIS DATABASE: MEMBERS LISTED IN DECEMBER 2023 ILLUSTRATED STATISTICAL REPORT

IRIS is the ICOM membership database.

IRIS is the Salesforce Customer Relationship Management (CRM) tool implemented for the General Secretariat, which manages ICOM members from their application to the payment of their membership, including their data, affiliation to an International Committee and their personal IRIS account.

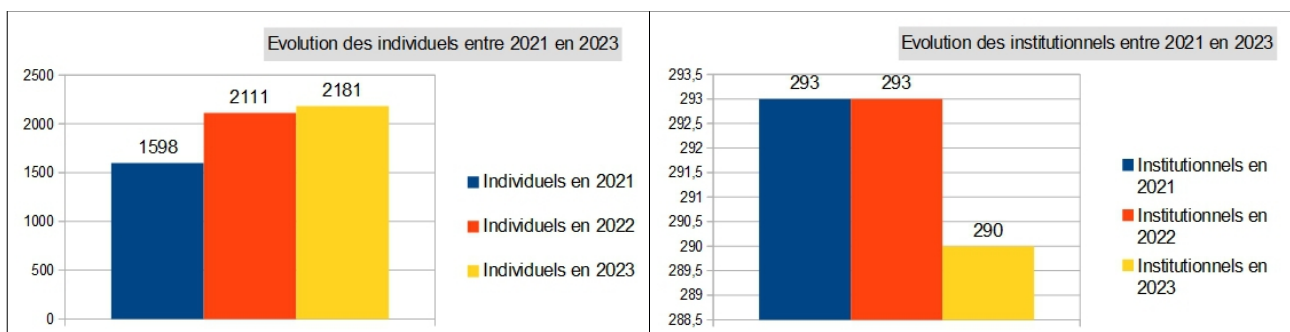
From the CECA's IRIS database, and at the President's request, the administrator can sort the data to group together targeted information over 1 or more years, on regions, countries, languages, types of members, their contact details and their institution. These extracts can be downloaded and used in Excel files.

This enables the manager to carry out statistics and thematic research for the organisation of the CECA's activities.

This also makes it possible to check that members are up to date with their subscriptions and their rights within ICOM and the International Committee (elections, voting, etc.).

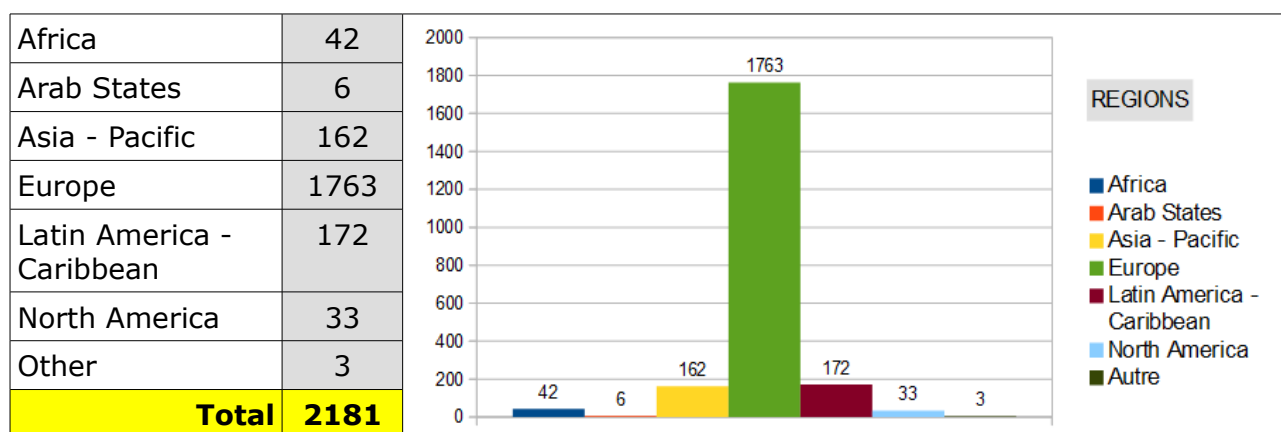
If there are any problems with a member's data, I inform the committee chair so that she can inform the ICOM General Secretariat.

Comparison of individual and institutional members between 2021 and 2023



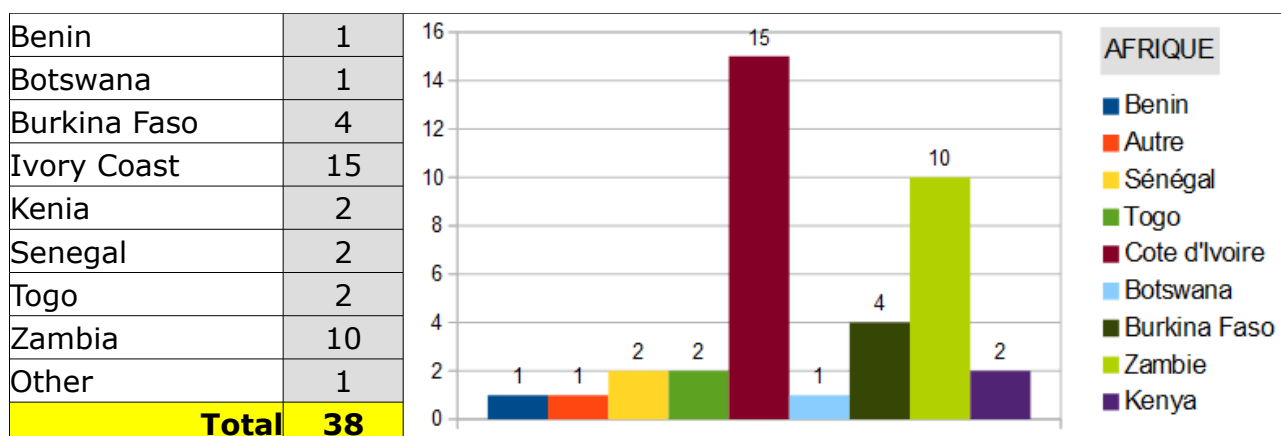

Individual members listed in the IRIS database in December 2023, by region

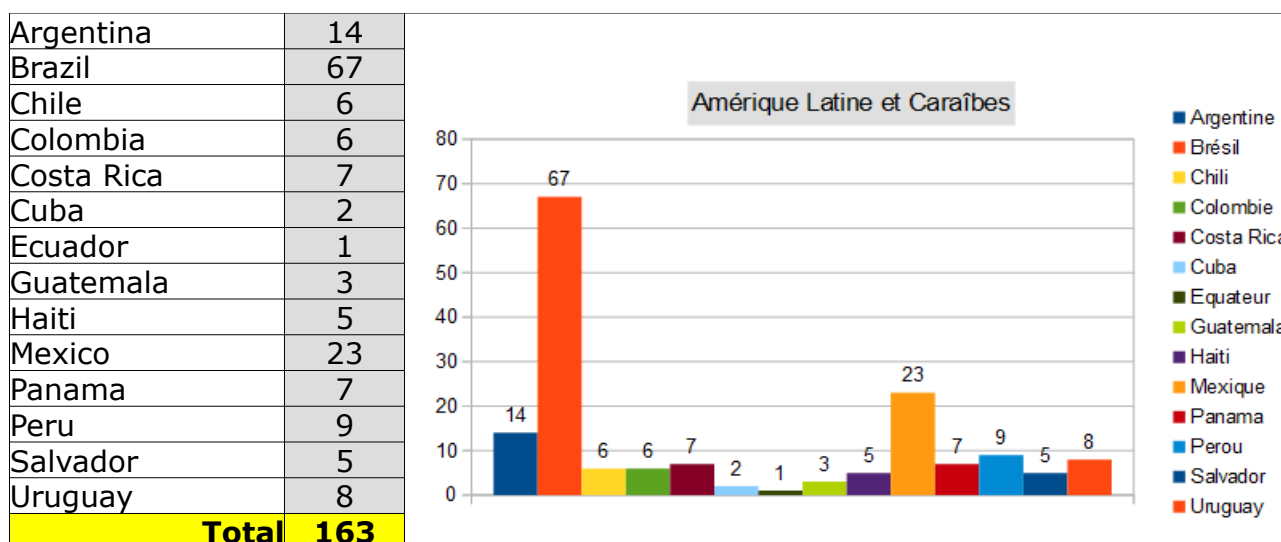


Individual countries by region

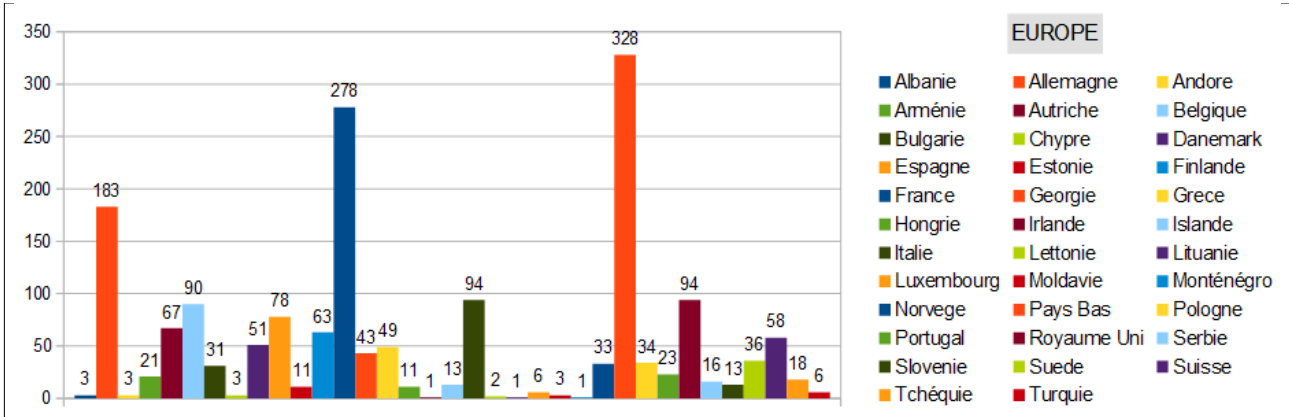

LATIN AMERICA AND THE CARIBBEAN

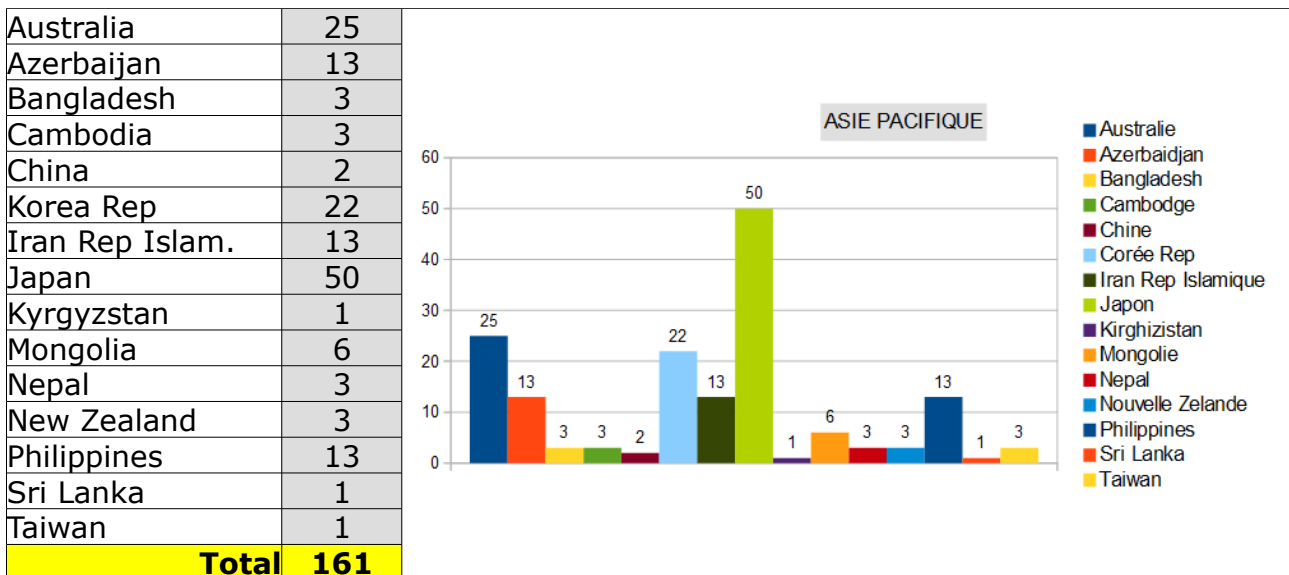

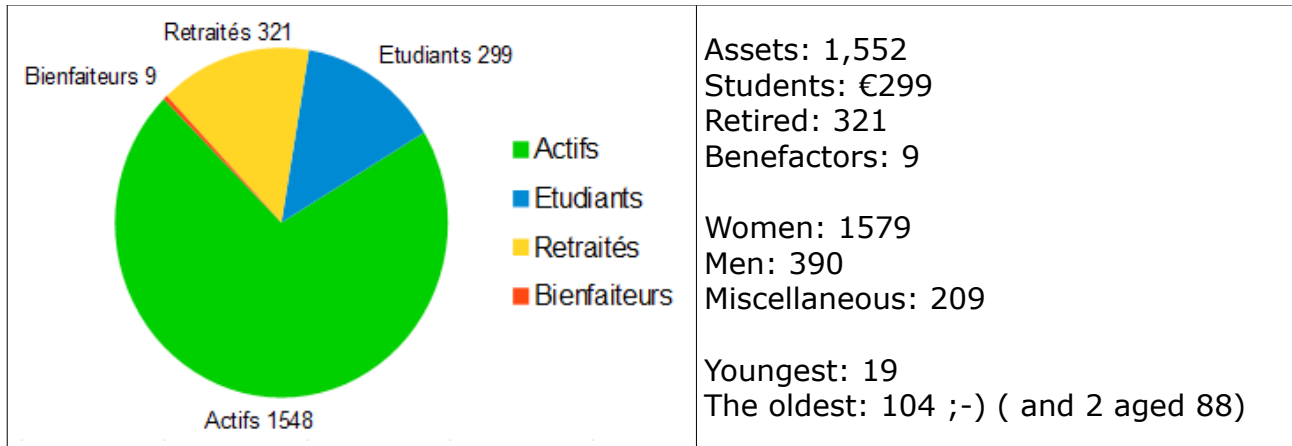


NORTH AMERICA by country / Canada: **33**

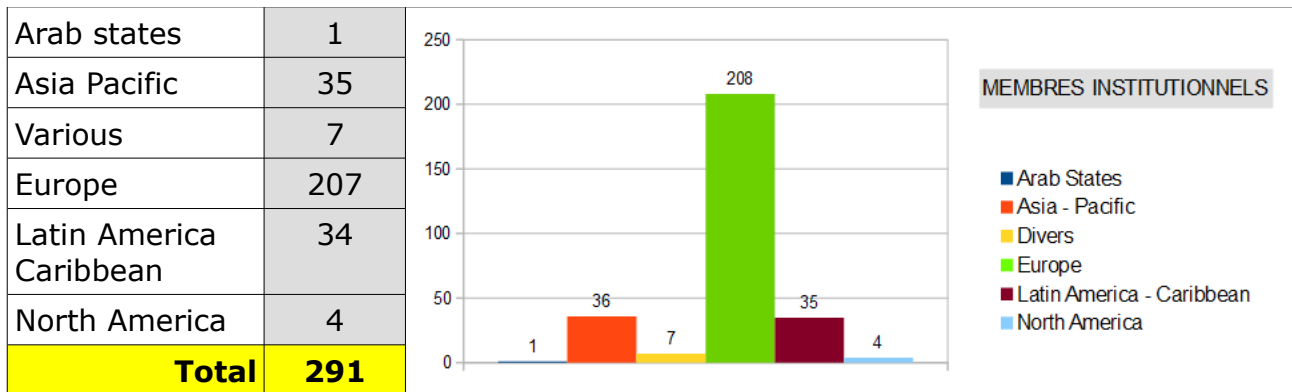
